PROCESS FOR REGISTRATION

1. Appoint an Approved Verifier or Certification Body to undertake the verification of your EPD
2. Complete this form and forward to the Australasian EPD Programme Secretariat
3. You will then receive an invoice for the annual fee (see terms and conditions below)
4. Upon payment, you will receive Australasian EPD registration number(s) for your EPD
5. Complete draft EPD, including Verification Report
6. Review the draft EPD against the checklist contained in the *Instructions of the Australasian EPD Programme (a Regional Annex to the General Programme Instructions)*. (2017) Version 2.0 Published 1.05.2017).
7. Make any necessary amendments and finalise your EPD
8. Send the following documents to the Secretariat for publication;
 - a. The final EPD (in MS Word or PDF document) in English
 - b. A copy of the verification statement or certificate of EPD Process Certification. For a construction product EPD, according to EN 15804-compliant PCRs, the [verification report for construction product EPDs](#) must be filled in and signed by the verifier
 - c. A short description, and high resolution picture of the declared product or service
 - d. Your company/association logotype.

9. You will receive an invoice for the registration and publication of your EPD on the Australasian and International EPD websites.

Annual Administration Fees

1. Where the company or trade association (Registrant) is applying for registration of their first Australasian EPD, the annual fee will be invoiced on receipt of this completed registration form. The annual fee becomes payable upon the appointment of the Verifier or Certification Body by an organisation and must be paid in full prior to the issue of an EPD registration number.
2. The Registrant is responsible for the accuracy of the EPD and providing updates where required due to product changes, changes to environmental indicators, or where errors or non-conformances are identified by, their Approved Verifier or Certifying Body, the Programme Secretariat or third parties. Note: updates to an existing EPD will incur an update administration fee.
3. Payment terms for the annual fee and EPD registration fee are the 20th of the month following the date of the invoice.
4. Fees are subject to change without notice.
5. Payment of invoices is evidence of acceptance of these Terms and Conditions.
6. The Australasian EPD Programme Limited reserves the right to temporarily withdraw or remove an EPD or related document from publication where (a) errors are identified, or (b) where payment terms are not met.
7. A decision to temporarily withdraw the document in question from publication would be made pending investigation or corrective action by the document owner.
8. The Registrant agrees to abide by the rules and procedures of the International EPD System General Programme Instructions, the Instructions of the Australasian EPD Programme – a Regional Annex to the General Programme Instructions, (2017) Version 2.0 published 1.05.2017, and any other Complaints and/or Grievance Policy and Procedures implemented by The Australasian EPD Programme Limited.
